## **Opinion**

In our opinion the directors are entitled under section 352 of the Companies Act 2014 to annex the abridged financial statements to the annual return of ABM Construction Limited ('the company') and those abridged financial statements have been properly prepared pursuant to the provisions of section 353 of that Act (exemptions available to small companies).

## **Basis of opinion**

We have examined :

- (i) the abridged financial statements for the financial year ended 31 October 2024 on pages 8 to 12 which the directors of ABM Construction Limited propose to annex to the annual return of the company; and
- (ii) the financial statements to be laid before the Annual General Meeting, which form the basis for those abridged financial statements.

#### **Opinion**

We have audited the financial statements of ABM Construction Limited ('the company') for the financial year ended 31 October 2024 which comprise the Statement of Income and Retained Earnings, the Balance Sheet and the related notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", issued in the United Kingdom by the Financial Reporting Council, applying Section 1A of that Standard.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 October 2024 and of its loss for the financial year then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", applying Section 1A of that Standard; and

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

## **NOTES TO THE ABRIDGED FINANCIAL STATEMENTS**

### **FOR THE FINANCIAL YEAR ENDED 31 OCTOBER 2024**

#### **1. GENERAL INFORMATION**

ABM Construction Limited is a company limited by shares incorporated in Ireland. The registered office of the company is Unit 2B, Feltrim Business Park, Drynam Road, Swords, Co. Dublin which is also the principal place of business of the company. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

#### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

##### **Statement of compliance**

The financial statements of the company for the year ended 31 October 2024 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

##### **Basis of preparation**

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

##### **Financial fixed assets**

Investments held as fixed assets are shown at cost less allowance for impairment.

##### **Trade and other debtors**

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts. If and only if the reasons for the impairment loss have ceased to apply, an impairment loss shall be reversed in a subsequent period.

##### **Trade and other creditors**

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

##### **Taxation and deferred taxation**

Current tax represents the amount expected to be paid or recovered in respect of taxable profits for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more tax in the future, or a right to pay less tax in the future. Timing differences are temporary differences between the company's taxable profits and its results as stated in the financial statements.

Deferred tax is measured on an undiscounted basis at the tax rates that are anticipated to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the Balance Sheet date.

##### **Foreign currencies**

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. The resulting exchange differences are dealt with in the Statement of Income and Retained Earnings.

**Ordinary share capital**

The ordinary share capital of the company is presented as equity.

**3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY**

Going concern

Notwithstanding the legal case pending against the company, the directors consider that there is no material uncertainty regarding the going concern status of the company and have a reasonable expectation that the company can continue in operational existence for the foreseeable future (i.e. a period of not less than twelve months from the date of approval of these financial statements). Accordingly, the directors continue to adopt the going concern basis of accounting in preparing the annual financial statements.

**4. PROVISIONS AVAILABLE FOR AUDITS OF SMALL ENTITIES**

In common with many other businesses of our size and nature, we use our auditors to prepare and submit tax returns to the Revenue and to assist with the preparation of the financial statements.

**15. CONTINGENT LIABILITIES**

Two legal proceedings have been issued against the company alleging the presence of pyrite in substructure fill material and claiming damages in respect of two buildings constructed by the company. In one of the cases, all proceedings between the parties were discontinued during the accounting period with no order of costs. No admission of liability whatsoever has been made by the company in respect of the outstanding case. The remaining action is being vigorously defended by the company. The directors, supported by their legal advisors, are of the opinion that the company should not have any significant risk or liability for this case. Accordingly, it is not considered probable that an outflow of resources, embodying economic benefit, will be required to settle any obligations alleged to be owing by the company. Whilst the ultimate outcome of the outstanding proceedings cannot presently be determined, other than the recognition of legal costs incurred, no provision for any additional costs or liability that may result has been made in the financial statements. Because of the ambiguous nature of the outstanding case against the company, the directors, supported by their legal advisors, consider they are not in a position to make a reliable estimate of any financial impact that may arise. In the considered unlikely event of the company being unsuccessful in its defence of this case, the company may be able to look to its insurance policy for reimbursement.
