### **1. General information**

Gaelic Trips Limited is a private company limited by shares incorporated in the Republic of Ireland. The registered office is 76 Santry Close, Dublin 9. The company number is 685652. The company is not being wound up.

### **2. Basis of preparation**

These financial statements have been prepared in accordance with the micro-entity provisions of the Companies Act 2014 and FRS 105, The Financial Reporting Standard applicable to the Micro-entities Regime.

### **3. Turnover**

The company had no turnover during the financial year.
