1. GENERAL INFORMATION

BHAILE CHRUAICH LIMITED is a company limited by shares with CRO registration number is 718027. CLOONSHECAHILL, NEW INN, BALLINASLOE, GALWAY, H53 WR24, Ireland is the registered office address. The principal activity of the company is Engineering activities and related technical consultancy. The financial statements have been presented in Euro (€), which is also the functional currency of the company.

2. ACCOUNTING POLICIES

Statement of compliance

The financial statements of the company for the period ended 31st January 2023 have been prepared on the going concern basis and in accordance with FRS 105 "The Financial Reporting Standard for Micro-Entities applicable in the UK and Republic of Ireland" (FRS 105).

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 105 "The Financial Reporting Standard applicable to the Micro-Entities Regime" issued by the Financial Reporting Council.

Accounting Convention

The financial statements are prepared under the historical cost convention.

Turnover

Turnover comprises the invoice value of goods supplied by the company, exclusive of trade discounts and value added tax.

Taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable profits for the year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Statement of Financial Position date.
