1. General Information

Haridale Limited is a dormant company that has never traded. Haridale Limited is a company limited by shares incorporated and registered in Ireland. The registered number of the company is 726552. The registered office of the company is 33 Upper Merrion Street, Dublin 2, Republic of Ireland which is also the principal place of business of the company. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

Basis of preparation

The company qualifies as a micro company as defined by section 280D of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Micro Companies Regime' in accordance with section 280E of the Companies Act 2014 and FRS 105.
