**(1) Statement of accounting policies**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

**a. Basis of preparation**

The unaudited accounts have been prepared in accordance with accounting standards generally accepted in Ireland and the Companies Act 2014. Accounting Standards generally accepted in Ireland in preparing financial statements giving a true and fair view are those issued by the Financial Reporting Council.

**b. Turnover policy**

Turnover represents the total invoice value, excluding value added tax, of sales made during the year.

**c. Taxation**

The yearly charge for taxation is based on the profit for the year and is calculated with reference to the tax rates applying at the balance sheet date.

**(2) Employees**

There were two employees during the year apart from the directors.

**(3) Accounting periods**

The current accounts are for a full year.

**(4) Approval of financial statements**

The board of directors approved these financial statements for issue on 18/01/2026.

## Statement of director`s responsibilities

The directors are responsible for preparing the Director`s Report and the financial statement in accordance with applicable Irish Law and regulations.

- State whether the financial statements have been prepared in accordance with applicable accounting standards, identify those standards, and note the effect and the reasons for any material departure from those standards; and
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.
