1. General information

The company is a private company limited by shares, registered in Ireland. The address of the registered office is Port Road, Letterkenny, Donegal.

The company will be operating in the renewable energy sector when it commences trading, it is currently dormant.

2. Statement of compliance

These financial statements have been prepared in accordance with FRS 105, 'The Financial Reporting Standard applicable to the Micro-entities Regime'.

3. Accounting policies and measurement bases

Basis of preparation

The financial statements have been prepared on the historical cost basis.

The financial statements are prepared in Euro, which is the functional currency of the entity.

Profit and loss account policy

The company is dormant as defined by section 365 of the Companies Act 2014. The company received no income and incurred no expenditure during the current financial year.
