Principal activities

The company has been dormant as defined in section 365 of the Companies Act 2014 throughout the financial year. It is anticipated that the company will remain dormant for the foreseeable future.

Dividends

The director and the secretary, at the financial year end, had no interests in shares in, or debentures of, the company or any group undertaking of the company.

Report on the audit of the financial statements

Opinion

We have audited the financial statements of Xport Transport Limited (the 'company') for the financial year ended 31 August 2025 which comprise the , statement of income and retained earnings, balance sheet, statement of cash flows and notes to the financial statements, including a summary of significant accounting policies set out in note 3. The financial reporting framework that has been applied in their preparation is Irish law and FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland.

In our opinion, the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 August 2025 and of its profit for the financial year then ended;
- have been properly prepared in accordance with FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland; and
- have been prepared in accordance with the requirements of the Companies Act 2014.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (Ireland) (ISAs (Ireland)) and applicable law. Our responsibilities under those standards are further described in the auditor's responsibilities for the audit of the financial statements section of our report. 1. General information

The company is a private company limited by shares, registered in Republic of Ireland. The address of the registered office is Unit 1A, Killeen, Silverstream, Monaghan, H18 WP77.

2. Statement of compliance

Basis of preparation
