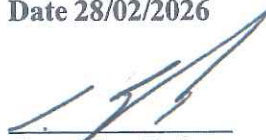

The directors do not recommend the payment of a dividend.

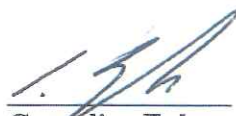
Directors' responsibilities
