### **Opinion**

## NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial year ended 28 February 2025

### 1. General Information

Jigginstown Management Company Limited By Guarantee is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 364462. The registered office of the company is c/o Qualitas Property Partners LTD., A1 Clonlara Avenue, Baldonnell Business Park, Baldonnell, Dublin 22, Co Dublin, D22WD63, Ireland. The principal activity of the company is the management of a block of 46 apartments at Wentworth Place , Jigginstown , Naas , Co. Kildare . The financial statements have been presented in Euro (€) which is also the functional currency of the company.

### 2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### Statement of compliance

The financial statements of the company for the financial year ended 28 February 2025 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

#### Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

#### Income

Turnover comprises the invoice value of services charges levied on members.

The obligation to pay Service Charges is one that each owner is legally bound to under the terms of their leases with the Management Company. The service charge debt is linked to the unit and this is never written off. All outstanding debts are ultimately collected from owners, in worst case scenarios, on sale of a subject unit.

#### Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

#### Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### Taxation and deferred taxation

The company is not liable to corporation tax as it is not carrying on a business for the purposes of making a profit.

#### Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. The resulting exchange differences are dealt with in the Income and Expenditure Account.

### Sinking Fund Contributions

In accordance with Section 19 of the Multi - Unit Developments Act 2011, the company must establish a sinking fund to fund non-routine maintenance and other non-routine costs that may arise from time to time. The Sinking Fund is not guaranteed to cover all unexpected costs of a non-recurring nature. These funds should be held in a separate designated bank account and are allocated to a special reserve titled "sinking fund reserve". Sinking fund contributions are recognised as income in the Income and Expenditure Account in the period in which large, non-regular repair and maintenance work is undertaken.

### 3. Common areas and location

The common areas of the development are in the process of being transferred to the management company.

### 4. Service Charges

The annual service charge and sinking fund amount per unit are agreed at the company's Annual General Meeting. The amounts will vary depending on the size of the unit.

### 5. Insurance

The company is insured with ZURICH Insurance with effect from its renewal date of 17/12/2024, cover as follows:

- Buildings: € 7,285,476
- Fire Brigade Charges: € 25,000
- Miscellaneous - Contents in Common Areas: € 29,776

The company has in force Directors & Officers cover through XL Group ( Angel) with effect from 09/12/2024.

### 6. Employees

There were no employees during the year apart from the directors, who were not paid a remuneration.

### 7. Prior financial year error correction

In the prior year, sinking fund contributions of €13,800 were collected from the members and accounted for as ordinary revenue reserve income. A prior year adjustment has now been processed to reflect the reallocation of these receipts to the sinking fund reserve. This has resulted in a reduction of reported total comprehensive income and accumulated revenue reserves for the year ended 29th February 2024 of €13,800 and a corresponding increase in the company sinking fund reserve as at 29th February 2024 of €13,800.
