NOTES TO THE FINANCIAL STATEMENTS

1. General information

The company is a private company limited by shares and is registered in Ireland. The address of the registered office is 41 Verschoyle Park, Saggart, Citywest Co Dublin Ireland

2. Basis of Preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost's convention. The financial framework applied in their preparation is the Companies Act 2014 and FRS 105 "The Financial Reporting Standard applicable to the Micro-Entities Regime" issued by the Financial Reporting Council.

The Company qualifies as a Micro- Company defined by Section 280D of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Micro Companies Regime' in accordance with Section 280E of the Companies Act 2015 & FRS 105.

3. Share Capital of The Company

The Ordinary Share capital of the company is presented as Equity.

4. Approval of Financial Statements

The Financial Statements were approved and authorised for issue by the Board of Directors on 13th June 2025

5. Preparation of FRS 105
