FOR THE YEAR ENDED 31ST DECEMBER 2025

1 Accounting policies

1.1 Accounting convention

The financial statements are prepared on the going concern basis, under the historical cost convention. The financial statements have been prepared in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2024).

1.2 Compliance with accounting standards

The financial reporting framework that has been applied in their preparation is the Companies Act 2015 and Accounting Standards issued by the Financial Reporting Council.

1.3 Turnover

Turnover Represents amounts receivable for goods and services bet of VAT and trade discounts.

1.4 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life, as follows:
