- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.



Directors' declaration on unaudited financial statements


In relation to the financial statements as set out on pages 4 to 5:





Notes to the abridged financial statements for the period ended 31.12.2024

1. Statement of accounting policies
