Opinion

In our opinion the directors are entitled under section 352 of the Companies Act 2014 to annex the abridged financial statements to the annual return of Forster Place Company Limited by Guarantee ('the company') and those abridged financial statements have been properly prepared pursuant to the provisions of section 353 of that Act (exemptions available to small companies).

Basis of opinion

We have examined :

The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", issued in the United Kingdom by the Financial Reporting Council, applying Section 1A of that Standard.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 May 2025 and of its profit for the financial year then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", applying Section 1A of that Standard; and

NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

1. General Information

Forster Place Company Limited by Guarantee is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 147226. The registered office of the company is Open Agency Property Management, Unit 13 Glenrock Business Park, Ballybane, Galway H91 D4F3 Ireland which is also the principal place of business of the company. The principal activity of the company is the management of the housing estate of Forster Place, Galway City. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the financial year ended 31 May 2025 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

Income

Turnover comprises the recharge of service charges to members of the housing estate.

Revenue recognition

Members are obliged to fund the service charges of the company annually. Management fees are recognised as income when invoices are raised following members' agreement at each annual general meeting. Members also agree the contribution to the company sinking fund under section 19 of the Multi Unit Development Act 2011. Funds raised are allocated to expenditures or reserves in the period to which they relate. The company maintains a separate bank account for the sinking fund.

Trade and other debtors

Trade debtors are amounts due from unit owners for services performed in the ordinary course of business.

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable income for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date.

Sinking Fund Contributions

In accordance with Section 19 of the Multi - Unit Developments Act 2011, the company must establish a sinking fund to fund non-routine maintenance and other non-routine costs that may arise from time to time. The Sinking Fund is not guaranteed to cover all unexpected costs of a non-recurring nature. These funds are held in a separate designated bank account and are allocated to a special reserve titled "sinking fund reserve". Sinking fund contributions are recognized as income in the Income and Expenditure account in the period in which large, non-regular repair and maintenance work is undertaken. The company has set up a separate designated bank account, and contributions have been made to same. Further transfers may be made to the sinking fund from liquid resources in each financial period.

3. Significant accounting judgements and key sources of estimation uncertainty

The directors consider the collectability of debtor balances at the year end and in doing so make estimates of amounts recoverable. All service charges are deemed collectable, as the charge is a contractual obligation. The directors consider impairment reviews at the year end and exercise certain judgments when reviewing balances outstanding for greater than 12 months.

4. Going concern

The financial statements have been prepared on a going concern basis. The directors have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future based on the satisfactory level of current assets. As a result they continue to adopt the going concern basis of accounting in preparing the financial statements. As with many multi-unit development companies, uncollected service charges may lead to short term cash issues for the company. The nature of such shortfalls is a reduction in future expenditures and/or the delivery of services for which the company is intended to provide. The directors maintain efforts to collect all outstanding charges due to the company which will enable it to deliver services.

5. Provisions Available for Audits of Small Entities

In common with many other businesses of our size and nature, we use our auditors to assist with the preparation of the financial statements.

Open Agency Property Management, as agent, provides management services to the company and oversees receipts and expenditures on behalf of the directors. The agent takes responsibility for the maintenance of proper books and records of the company and compliance by the company with the Multi Unit Development Act 2011. During the year the company incurred property management fees of €2,454 (2024: €2,276).
