**Accounting Records**



The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable Irish law and regulations.



# **INDEPENDENT AUDITOR'S REPORT TO THE SHAREHOLDERS of Hannahmay Limited**

## **Report on the audit of the financial statements**

### **Opinion**

We have audited the financial statements of Hannahmay Limited ('the company') for the financial year ended 31 December 2021 which comprise the Income Statement, the Statement of Financial Position, the Statement of Changes in Equity and the related notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued in the United Kingdom by the Financial Reporting Council.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 December 2021 and of its loss for the financial year then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland"; and
- have been properly prepared in accordance with the requirements of the Companies Act 2014.

### **Basis for opinion**



## 1. General Information

Hannahmay Limited is a company incorporated in Ireland. 23/25 Sundrive Road Dublin 12, Ireland is the registered office, which is also the principal place of business of the company. The nature of the company's operations and its principal activities are set out in the Directors' Report. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

## 2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

### Statement of compliance

The financial statements of the company for the year ended 31 December 2021 have been prepared on the going concern basis and in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102).

### Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280B of the Companies Act 2014 in respect of the financial year and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014.

### Income

Rental income from investment property is accounted for on an accrual basis.

### Financial assets

Investments held as fixed assets are stated at cost less provision for any permanent diminution in value. Income from other investments together with any related withholding tax is recognised in the Income Statement in the year in which it is receivable.

### Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

### Employee benefits

The company does not operate a pension scheme.

### Taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable profits for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Statement of Financial Position date.

### Share capital of the company

#### Ordinary share capital

The ordinary share capital of the company is presented as equity.

## 3. Turnover

The whole of the turnover is attributable to the principle activity of the company which is wholly undertaken in Ireland.

The company has received debt finance from Courtstown Island Enterprises Unlimited Company. This debt is secured by way of charge over the assets and undertaking of the Company including specific fixed charge over the property known as Buckley's Galleries, numbers 27 and 28, Sandycove Road, Dun Laoghaire, a charge over insurance proceeds, a charge over shares, a floating charge over the book debts, assets and undertaking and all property of the Company.

In addition, the company's immediate parent, Meia Duzia Limited, has granted a charge to Courtstown Island Enterprises ULC over all its assets and undertaking.

### 12. Controlling party

The immediate parent company is Meia Duzia Limited which itself is 75% owned by Nicholas McAuliffe so the company is ultimately controlled by Nicholas McAuliffe.

### 13. Going Concern

The financial statements have been prepared on the going concern basis and no adjustments have been made in case this basis is not appropriate. The company has received a loan and that loan is in default. This may trigger the lender to call in the facility and related guarantees. This may cast significant doubt over the company's ability to continue as a going concern.

### 14. Approval of financial statements

The board of directors approved these financial statements for issue on 16 February 2026
